RESOLUTION NO. 16-2024**

**A RESOLUTION OF THE TOWN COUNCIL OF CENTREVILLE TO ADOPT A REVISED
CEMETERY FEE SCHEDULE**

WHEREAS, the Town Charter gives the Town Council of Centreville the power to regulate and control the Chesterfield Cemetery.

WHEREAS, Section 42-3. B of the Town Code authorizes the Town to do interments.

WHEREAS, by Resolution 11-2020 the Town Council adopted the current Chesterfield Cemetery Fee Schedule; and

WHEREAS, the Town Council wishes to update the Chesterfield Cemetery Fee Schedule; and

NOW THEREFORE, the Town Council of Centreville hereby resolves as follows:

Section 1. The recitals set forth above are incorporated herein by reference and made a part of this Resolution;

Section 2. Section III of the Town of Centreville Chesterfield Cemetery Fee Schedule is hereby amended to read as follows:

SECTION THREE: AND BE IT FURTHER RESOLVED that the following prices shall be charged for burial spaces, niches, cremains, and interments in the Chesterfield Cemetery, to wit:

B.	Columbarium	\$1,800	
C.	Flat Fee Monument Installation	\$60	<u>\$100</u>
D.	Monday thru Friday Internment (except holidays) ¹

	<u>Internment at Double Depth²</u>		<u>\$1,188</u>
	Infant Internment	\$525	<u>\$313</u>
	Cremated Remains	\$525	
E.	<u>Weekend & Holiday Fees Subject to Funeral Home Contingency</u>		
	<u>Saturday</u>		<u>\$400</u>
	<u>Sunday</u>		<u>\$600</u>
	<u>Holiday Service³</u>		<u>\$800</u>
F.	Archived Records Flat Fee	\$15	

¹Funerals taking place after 3:00 p.m. require an additional \$100 paid directly to the contractor.

²Double depth internment is for previously purchased double-depth lots. Double depth lots are no longer available for purchase.

³Holiday Service – New Year’s Day, Easter Sunday, Memorial Day, July Fourth, Labor Day, Thanksgiving Day, and Christmas Day. These fees are in addition to fees stated in D above.






